- The term of the Chairperson and members shall be for a period of **two years**
- The term of Special Invitee shall be for a period of **one year**
- The quorum for the meeting including the Chairperson, but excluding the Special Invitee shall be **three**
- In considering the grievances before it, the SGRC shall follow the principles of natural justice.
- The SGRC shall send its report with recommendations, if any, to the Competent Authority of the University and a copy thereof to the aggrieved student, preferably within a period of **15 working days** from the date of receipt of the Complaint.
- Any student aggrieved by the decision of the SGRC may prefer an appeal to the Ombudsperson, within a period of **15 days** from the date of receipt of such decisions.

This notification replaces all earlier orders issued in this regard.
